A number of high profile visitors, such as from Afro-Asian and Middle-East Countries, a team of IAS Officers and a World Bank Team visited RSETIs/ NACER to acquaint themselves with the work being done by the RSETIs/NACER.

More than 185 RSETIs now have their own full-fledged premises and another 100 RSETIs will have their own campuses by 31.03.2019.

**MOU** between MoRD and NAR was successfully renewed for a further period of three years i.e. upto 31.07.2020.

RSETIs have crossed **new milestones** in terms of performance, by training **over 26 Lakh** candidates in about last six years with settlement of **over 17 Lakh**.

The achievements as above are not only significant but also cast new responsibilities on all of us to further improve upon the excellent performance in the coming year. I am quite sure that your RSETI will contribute its mite in this regard.

## PREAMBLE

Swami Vivekananda visualized a regenerated India through blending of oriental spirituality with occidental science & technology. He emphasized on the importance of studies of history, geography, science & technology along with higher truths of religions. With this mission in mind “Ramakrishna Mission Samaj Sevak Sikshan Mandir” started its maiden journey in the year 1986 under the aegis of Ramakrishna Mission Saradapitha, a branch centre of Ramakrishna Mission, Belur Math, Howrah, West Bengal. In the same year the flagship training programme of the institute – 10 month long free residential course viz. 'Rural Entrepreneurship Development Programme' was launched with the following objectives:

## OBJECTIVES & CHARACTERISTICS

- ◆ To develop human resources in the rural sector and to improve their socio-economic status through employment generation.
- ◆ To upgrade the traditional knowledge and skill of the farmers and the rural artisans.
- ◆ To create scientific temperament amongst the rural folks and an eagerness to adopt new technology and innovation.
- ◆ To build character on the basis of higher truths of spirituality and value education.
- ◆ To instil confidence and determination in the minds of trainees.
- ◆ To conduct short-term in-campus and off-campus training programmes sponsored by various government & other agencies.
- ◆ To generate confidence & determination so that the trainees can venture to float new enterprises for self-employment at their respective villages.



## IMPORTANT MOVEMENTS IN THE HISTORY OF THIS INSTITUTE

- ◆ In the year 2007-08 (17<sup>th</sup> March 2008) the institute entered into a tie-up arrangement with UBI (United Bank of India) and NABARD (National Bank for Agriculture & Rural Development) to function as a RUDSETI (Rural Development & Self Employment Training Institute) type institute for conducting various training programmes on equal cost sharing basis.
- ◆ The flagship training programme of 10 months' duration named REDP (Rural Entrepreneurship Development Programme) was subsequently followed by introduction of various employment generation training programmes of short duration. Apart from the REDP, various short duration programmes are held at the sub-centres scattered over various districts of West Bengal. These are SDI (Skill Development Initiative) training programmes. SDI programmes are generally non-residential and held on various trades in farm & non-farm sectors sponsored by NABARD / Govt. of West Bengal / Govt. of India etc.
- ◆ During the course of its long journey some events of 2011-12 and 2012-13 deserve special mention. On the basis of its performance during 2011-12 the institute earned 'A' grade and on the performance of 2012-13 ranked 3<sup>rd</sup> best RSETI amongst all the RSETIs in India by NAR (National Academy of RUDSETI) under the Ministry of Rural Development (MoRD), Govt. of India.
- ◆ Till now the Institute continues to uphold the grade status “AA”. Several other short term training programmes are sponsored separately by NABARD, West Bengal Swarajgar Corporation Ltd (WBSCL), Coconut Development Board (CDB), Govt. of India; Hindalco Industries Ltd. etc.

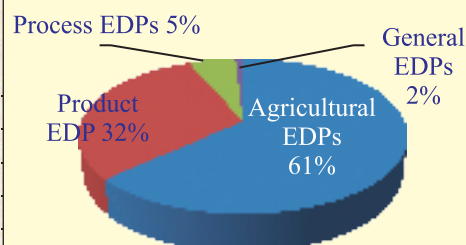

## SPECIAL STATUS

## INFRASTRUCTURE

The gradually build up three storied magnificent building with 10000 Sq. ft. covered area was formally inaugurated in the year 2011 coinciding with the Silver Jubilee Celebration of the Institute. The RSETI is spread over vast area of manicured garden & greenery. The milieu is ideal for learning & concentration.

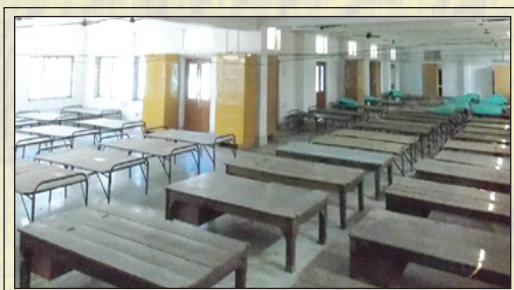


The building is having number of spacious class rooms, Office room, staff room, Principal's Office & living room, Dormitory for the trainees, guest rooms, meeting and counselling room, conference hall, computer lab, gymnasium, library etc. besides a number of toilet blocks & long and widening corridors. The institute is having a very big dining hall adjacent to the kitchen & near the REDP students' hostel. At present residential training of more than 100 trainees can be organised simultaneously

at the institute. The institute is thankful to the Dept. of Agriculture, Govt. of W.B for providing grant-assistance for construction of the new building under RKVY (Rastriya Krishi Vikash Yojana).

## TRAINING COURSES

Under the REDP free residential comprehensive training of 10 months' duration is given to 40 odd unemployed candidates each year hailing from rural Bengal purely on the basis of merit irrespective of their caste, creed and religion. Apart from this flagship programme, various short duration EDP and other in-campus & off-campus specified training courses on various trades under both farm & non-farm sectors are conducted. Detailed course programmes are categorised hereinafter.



The 32nd session of the flagship programme of the Institute viz. REDP (Rural Entrepreneurship Development Programme) a 10 month long course on Agriculture & Allied Activities concluded successfully on March 14, 2018. This year 26 trainees have successfully completed the course.

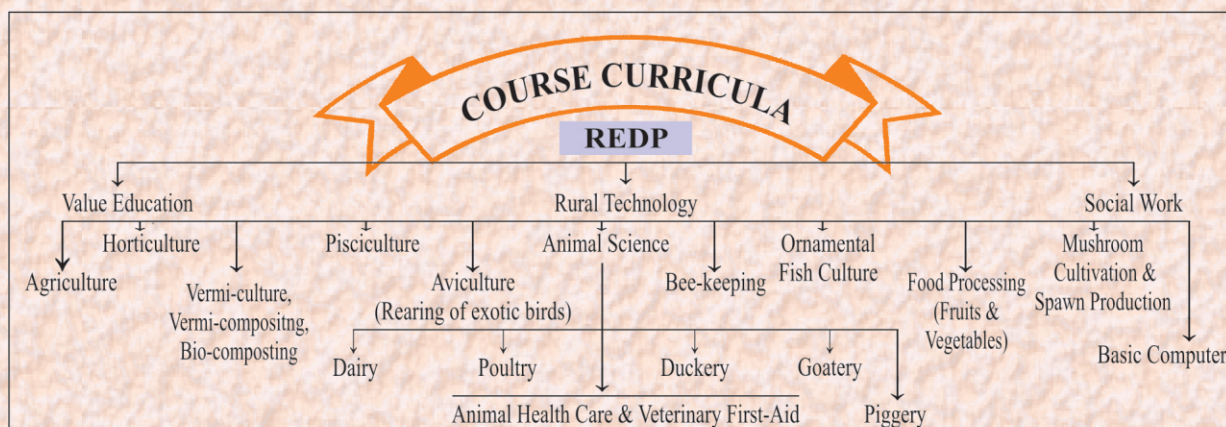

### ADMISSION PROCEDURE

The intending trainees are to apply against newspaper / website advertisement of the Institute. Those fulfilling the admission criterion are shortlisted for admission after written test & personal interview.

### DAILY ROUTINE

The Day starts at 5-00 a.m. and ends at 10-00 p.m. Seemingly, this is a rigorous schedule but made enjoyable through combination of training & recreation. Two times Prayer, in the morning and evening, "Sramadan" for up-keeping the wide-spread campus clean and habitable, on-the-job training in the agricultural field adjoining the institute, physical exercise in the gymnasium, music class, outdoor games - all these forms the essential fabric of the daily routine besides theoretical classes. With the progress of the training course - the trainees feel a unique bondage with the institute and they themselves voluntarily come forward at its every call even years after their passing out.

### COURSE COVERAGE

Training discipline, inter alia, includes Agri-Horticultural practices, Sericulture, Poultry, Duck Rearing, Pisciculture including Ornamental Fish Cultivation, Animal Husbandry & Animal Health Care, Apiculture, Aviculture, Mushroom cultivation & Spawn culture, Vermiculture & Vermicomposting, Food Processing etc. along with Environment & Sanitation, Primary Health Care, Agricultural Extension, Entrepreneurship Development, Social Studies, Organisation building, Basic Computer and Value education. Training curriculum includes both in-house training and field exposure. Apart from all these, the trainees are given lessons on importance of Financial literacy, Financial awareness and elementary Banking.



## HIGHLIGHTS OF ACTIVITIES

### SUBJECT SPECIFIC FOCUS

#### AGRICULTURE

Agriculture with Soil Fertility & Soil Testing Procedure, Quality Seed Production, Integrated Plant Nutrient Management, Integrated Pest Management, Watershed Management etc.

#### HORTICULTURE

Agronomical crops, Pomology, Floriculture and Olericulture, horticultural nursery etc.



#### ANIMAL HUSBANDRY

Animal Husbandry and Animal Health Care including Dairy, Goatery, Poultry, Duckery, Veterinary First-aid etc. are given due weightage considering their importance in rural economy and self-employment.



#### PISCICULTURE

Cultivation of Indian Major Carps and other species of fish. Inland Fishery

includes hatching, nursing, rearing and induced fish breeding, farm made fish breeding & seed management occupies an important role in the training curriculum.



#### FOOD PROCESSING

The Institute's training-cum-production unit on food processing is used for training on Processing and Preservation of fruits & vegetables (Various Types of Jam, Jelly, Pickles, Squash, Tomato Ketchup, Chilli Sauce, Honey, Amlapras, Papad etc.). The unit is having state of the art machineries and appliances.



#### COMPOSTING

The trainees are actively involved in preparation of Bio-Composting, which includes Super-Compost, Azolla, Vermi-compost as-well-as preservation and multiplication of suitable species of earthworms by utilising the compost pits specially constructed for this purpose within the premises of the Institute. Bacteria is also used for composting.





### AVICULTURE & CONSERVATION OF BIRDS (EXOTIC)

Keeping in view the emergence of Aviculture (rearing, breeding of exotic birds only) as an important field of entrepreneurship and also the importance of conservation of exotic birds, practical training along with theoretical classes are arranged in the Aviary at the institute premises.

### ORNAMENTAL FISH CULTURE

Cultivation and multiplication of different types of Ornamental Fishes including its management practices have been incorporated in the course curriculum. This has emerged as a sure avenue of income generation for the trainees



### APICULTURE

Honey-bees not only provide honey and wax but they also greatly contribute towards pollinating the insect-pollinated crops and thereby help in increasing agricultural production. Scientific Bee-keeping methodology in bee boxes along with its proper management round the year is taught to the trainees to help them understand how Bees help the bee-keepers & the farmers.



### MUSHROOM CULTIVATION

During the training the trainees are taught about the cultivation and other management practices of different species of mushroom. With an object to providing quality mushroom spawn (seed) to the ex-trainees a laboratory for production of mushroom spawn has been established at the institute which effectively caters to the need of mushroom spawn of the ex-trainees in their new ventures.



### DUCKERY

A Duckery unit is maintained inside the campus where 25 number of ducks of 'Chara Chameli' species have been reared.

## POULTRY

The unit is enriched with the various varieties of birds received from farms owned by Government of West Bengal as gift. These birds are used for the purpose of Poultry training.

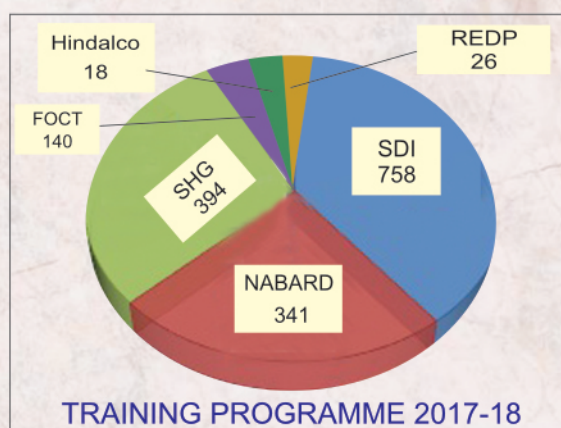

## MECHANICAL HARVESTING OF COCONUT & COCONUT PLANTATION MANAGEMENT SPONSORED BY COCONUT DEVELOPMENT BOARD, GOVT. OF INDIA

This programme was introduced in the year 2014-15. Under this programme the trainees are taught inter cropping in coconut garden, nutrient management, insect management of coconut trees, mechanical climbing, coconut Olympiad etc. A climbing machine worth Rs.3500/- is given to all the participants, courtesy Coconut Development Board, Govt. of India as a post training support. During the year four training programmes were conducted involving 140 trainees. Like in other training programmes in this programme also Financial awareness, Financial literacy and elementary banking are taught.

On the basis of positive feedbacks received, such type of programmes were conducted in 2017-18 also. The trainees have immensely benefited from these programmes.



### AWARENESS CAMPS

During this year 2017-18 a total of 62 nos. of awareness camps have been organised in the institute and outside spread over different districts. In those camps around 2968 youths mostly women belonging to weaker section and small & marginal farmers have actively participated.



### SENSITIZATION PROGRAMME

- Day long sensitization programme for the entrepreneurs was organized by the Nehru Yuba Kendra, Kolkata at our Seminar Hall on July 21, 2017.
- Day long sensitization programme for newly recruited Probationary Officers of United Bank of India was held on December 24, 2017 at our Seminar Hall.



### VISITING FACULTY MEET:

Like previous years the visiting faculty met on May 30, 2017 and evaluated the training programmes and discussed the future strategies. Twenty five visiting lecturers & resource persons from different discipline attended the meeting.

### VISIT FROM OTHER INSTITUTIONS:

30 students from Bagnan College visited our Food Processing Unit on 10.03.2018 as part of their study tour.



### INSTITUTIONAL PLACEMENT / STUDY TOUR

During the period under review the trainees of the 32nd REDP batch were placed to different Govt. farms for undergoing hands-on training in various aspects of agriculture and allied activities like Induced Breeding in Fish, Dairy Management, Animal Health Care, Poultry, Piggery, Goat Rearing, Duck Rearing etc. as per the details given hereunder:

- a) The trainees were placed to one week (seven days) fishery training camp from **July 10 to 16, 2017** at the Central Institute of Freshwater Aquaculture, ICAR, Rahara where they underwent intensive field training on **Induced Breeding of Fish and Seed Management**.
- b) The trainees were placed to one week (seven days) training camp from **September 20 to September 25, 2017** at Agriculture Training Centre of Dept. of Agriculture, Govt. of W.B at Chinsurah, Hooghly where they underwent intensive Agri-Horticultural training practice. This placement greatly compensates the absence of large agricultural farm at our institute.
- c) The trainees were placed to one-month long training camp from **November 01 to 30, 2017** at Haringhata farm, Kalyani, under Animal Resource Development Dept, Govt. of West Bengal, where they have undergone intensive practical training on Dairy Management, Animal Health Care, Poultry, Piggery, Goaterly, Duckery etc.

## FIELD WORK CAMP

Trainees were placed in six days' field camp from February 19 – 24, 2018 accompanied by 10 teachers on various subjects with a view to enhancing the students' self-confidence. During the camp period the activities were covered with the aspects of agriculture, horticulture, soil science, nutrient management (crop production), pest control, animal health care with disease diagnosis and treatment, animal vaccination and fish culture. The camp activities were extended to 4 villages viz. Simdal, Poduma, Saidabad and Bazardanga within the radius of 2 – 4 KM of the base camp at Simdal Sri Ramakrishna Ashrama under Kotulpur block of Bankura district. During the period socio-economic survey was conducted by the trainees which covered 65 local families. Besides this, free treatment including supply of medicine was done for 5484 nos. of animals (cow, calf, buffalo, goat, dog, poultry, duck and exotic birds etc. & the species mentioned above were vaccinated. Twenty women from the members of SHGs of 2 (two) villages were trained on Food Processing & Preservation of fruits. Mixed vegetable pickle, papad, green mango jam, orange squash, tomato sauce etc. were produced on spot by the trainees. Collection & testing of 16 nos. of soil samples from the fields were done at free of cost. The camp was found to be very much helpful to the trainees and villagers as well.



## VIGILANCE AWARENESS PROGRAMME

Vigilance awareness programme was held on October 31, 2017 at our Seminar Hall organised by United Bank of India, Hooghly Region as a part of observing vigilance awareness week from October 30 to November 05, 2017. Our Principal Maharj inaugurated the programme with the lighting of lamps. Officer of UBI, Hooghly Region and our local Branch Manager, UBI were also present. The trainees of the institute also took the integrity pledge.

## POST-TRAINING SUPPORT SERVICE

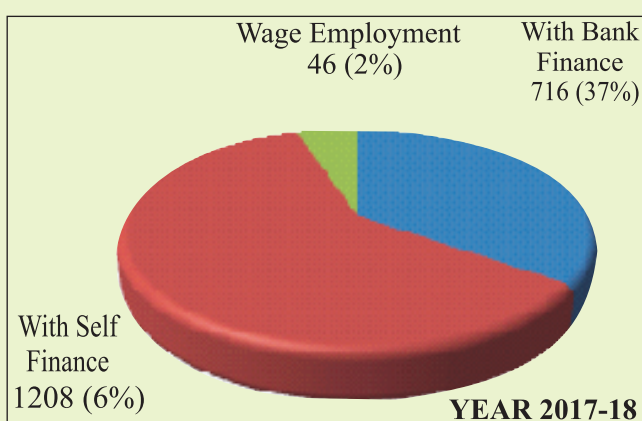
Due to the participation in 10 month long residential programme very close relation develops between the trainees and the Institute and this makes regular follow-up with them much easier. Ex-trainees maintain close contact with the Institute and all possible post-training support services are provided to them. They visit the institute as and when required and consult the specialist faculties on different subjects regarding various problems encountered by them in implementing their projects. Conversely, the resource persons pay occasional visit to the project sites set up by the trainees. Necessary arrangements for financial assistance by way of self-employment loan and linkage with bank have been arranged for the ex-trainees for undertaking different self-employment initiatives.

## FOLLOW-UP

- One follow-up meeting with the REDP trainees of 2017-18 batch was organised at the Institute.
- One follow-up meeting with the ex-trainees of earlier batches of REDP course was organised at the institute on 15.03.2018 where 102 number of ex-trainees participated.
- Personal contact is being maintained with the ex-trainees to provide constant guidance to them in pursuing their vocation. The trainees are assisted in preparation of project proposals and filling of application forms for availing credit support from banks.
- During the year under review participants of 130 (one hundred thirty) Training Programmes representing 2320 candidates under Agricultural EDP, Product EDP, Process EDP and General EDP were followed-up during 205 visit. Such hand holding continues for 2 years after the training.
- Follow-up programmes have been further improved through MIS data base system
- Follow-up visits are conducted on-spot as per the direction of NAR.

## SETTLEMENT OF TRAINEES

Out of the **2320** number of trainees contacted for follow up, **1208** trainees have set up their units with own funds, **716** trainees availed loans like KCC, SHGs and another **46** trainees are presently employed in different organisations.

## TALES OF SUCCESS

### NAME OF THE ENTREPRENEUR : SHRI ARANI GUPTA MAZUMDER

Shri Arani Gupta Mazumder, Son of Shri Phalguni Mazumder was a student of 31st batch of REDP course, the 10 month long residential training programme on agriculture and allied subjects of Ramakrishna Mission SamajSevakSikshanMandir, Belur Math, Howrah. He is from Vill.- Teghari, P.O., P.S. & Block- Aranbagh, Dist.- Hooghly-712601, West Bengal.

After obtaining Master Degree in Social Work (MSW) Shri Arani Mazumdar was on the look out of a suitable profession for himself. At that time he came into contact with the Ramakrishna Mission Samaj Sevak Sikshan Mandir and its flagship programme – Rural Entrepreneurship Development Programme (REDP). He quickly enrolled himself in the 31<sup>st</sup> batch of REDP for the year 2016-17.

From his childhood he had a dream of setting up an integrated organic agriculture farm. The 10 month long residential training at the Ramakrishna Mission Samaj Sevak Sikshan Mandir, Belur Math on rural entrepreneurship development fired his imagination and he started believing on his own ability. He received holistic training on varied disciplines under both farm & Non-farm sectors including lessons on entrepreneurship development skill.



Shri Mazumdar is an educated, enterprising young man who is consistently trying to establish himself by developing the activities of his organic agriculture farm viz. Sri Sri Krishna Roy Krishi Khetra at Arambagh. His farm is situated on one hectre land in Teghari village, roughly two kilometres from Aragmbagh town. The land is owned by a religious trust formed by his ancestors. He has set up Dairy, Fishery, Duckery, Goatery units. In the dairy unit there are 3 crossbreed cows with two calves and the per day average milk production is 30 litres. Fishery unit has already started with 4250 pcs of fingerling of Indian Major Carps and Indian Mino carps. The shed for the goatery unit has already been constructed. United Bank of India, Arambagh Branch has granted a loan of Rs.38,700/- under the MUDRA Yogana for starting the Duckery unit. Organic vegetables and crops are also being produced on 5 bigha farm land. The farm is also making organic fertilisers & pesticides. Projects on production of vermicompost and construction of Azola pit is in the pipe line. Shri Arani has so far engaged 3 (three) persons in his venture.

Shri Mazumder has invested around Rs.2,50,000/- in this venture. From his own and family sources he has invested Rs.200,000/- balance amount he has contributed from bank loan and other sources.

Shri Arani is still a bachelor and lives along with his parents in a small family. With the present level of average monthly income of Rs.30,000/- he is doing reasonably well and he possess huge potentiality of a successful entrepreneur.

#### NAME OF THE ENTREPRENEUR : SM. KAKALIADAK

Vill.-Purbapara, P.O. Ajodhya under Shyampur -II Block, Dist.- Howrah

This is the story of a traditional house-wife from a lower middle class Bengali family. Sm. Kakali Adak W/O of Shri Subrata Adak of village Purbapara, Post - Ajodhya under Shyampur-II block of Howrah District. She took a training on Women's Tailoring from Belpukur Shri Ramakrishna Vivekananda Pathachakra, a sub-centre of Ramakrishna Mission SamajSevakSikshanMandir, Belur Math during 2014-15. Prior to the training she was fully dependent on her husband. After successful completion of the training she got a loan of Rs.50,000.00 from her SHG group. Then she had opened a ladies' garment production-cum-sale unit, named Adharsha Ladies Tailors in a rented accommodation near her residence. She procures the raw materials from Burrabazar, Kolkata at a competitive price. As a trainee she was very attentive. Her devotion paid rich dividend. The quality of her craftsmanship has endeared her to the clientele. Her charming manners and quality of garments resulted in creation of good customer base. Practically, her business grew by leaps and bounds.

To cope with the volume of business she had to engage 4/5 tailors at her production site. Her husband who was in poultry business had to close the unit and join his wife's business to lend her support. She had invested around Rs.10,00,000/- in the business, out of which Rs.50,000/- came as bank loan.

Now, her monthly income is around Rs.50,000/- after adjusting all business expenses. She is really an example to other budding entrepreneurs striving to establish themselves.

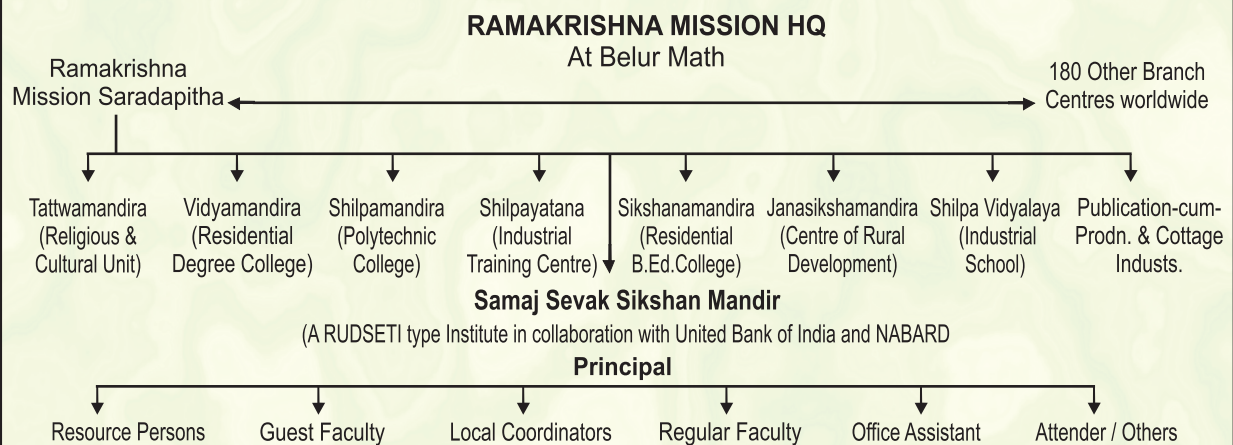
