A brief report of activities of the institute for the period from **July to September, 2019** was placed at the meeting by the Principal and kept on record.

## Agenda 4. Follow-up & Monitoring (Appendix 25) / Credit Linkage of Trainees / Evaluation:

### a) Follow-up & Monitoring (Appendix 25):

- i) Personal contact is being maintained with the ex-trainees for providing constant guidance to them in pursuing their vocation. The trainees are assisted in preparation of project proposals and filling-up the application forms for availing credit support from banks.
- ii) Follow-up of **11 (eleven)** nos. of training programmes were completed. Out of total **281** trainees, **160** trainees have set up their own units with own fund, **45** trainees have set up their units with bank loan, **6** trainees are presently employed in different organisations, remaining **70** trainees are yet to be settled during the period under review. Percentage of settlement stands at **75%** during the period under review.
- iii) Appendix 25 (format of quarterly report – post training evaluation of last 50 batches) for the quarter ending **September 30, 2019** was placed in the meeting and kept on record.

### b) Credit Linkage of Trainees:

- i) KCC / SHG Loan Obtained:  
Another **45 (forty five)** trainees have received bank loan from KCCs / SHGs during the period under report.
- ii) Stand-up Mitra Portal:  
**48 (forty eight)** nos. of loan applications have been uploaded in the Stand-up India Portal during the period under report.

**b) Claim for NRLM Target Group Candidates:**

Principal, RKMSSSM informed the house about the submission of reimbursement of training expenses of **367 (three hundred sixty seven)** Rural Poor / NRLM Target Group candidates amounting to **Rs.10,13,590.00** (Rupees ten lakh thirteen thousand five hundred ninety) only during the period from **April to September, 2019**. Resolved that the claim for the said amount i.e. **Rs.10,13,590.00** (Rupees ten lakh thirteen thousand five hundred ninety) only be sent to the WBSRLM through United Bank of India, Head Office for reimbursement.

**Agenda 6. Any other matter with the permission of the Chair:-**

In the DLRAC meeting dated **11 April 2019**, NABARDs representative requested RKMSSSM to increase the number of Non-farm sector training programmes vis-a-vis the number of Farm sector training.

Prior to that, the house discussed the matter and NABARD representative came forward with a proposal which can help us in organising various Non-farm sector training programmes under their auspices. The proposal was discussed and accepted by the house in the DLRAC meeting dated **October 14, 2019**.


In view of the above, it was concluded that RKMSSSM be advised to approach NABARD with a proposal to hold various Non-farm sector training programmes under their financial support.
